GAS EASEMENT

For and in consideration of the sum of \$ 1.00 paid, receipt of which is hereby acknowledged, I/we, Jerrold Brent Adkisson grant unto the Harriman Utility Board, operating agency for the City of Harriman, Tennessee, a perpetual easement described as follows;

A strip fifteen feet (15') in width, lying seven and one half feet (7 1/2') on either side of the center line of a Gas line to be installed on the hereinafter described property at location known and agreed to by the parties hereto, plus a temporary construction easement, for purposes of installation only, extending five feet (5') beyond the boundary of the permanent easement;

for the purpose of installing, operating and maintaining said Gas line as well as rights of ingress and egress to and from said line for these purposes over the following described property:

Situated in the First Civil District of Roane County, Tennessee, being that property owned by the Grantor and referenced by will, deed, or deeds, of record in the Office of the Registrar for Roane County, Tennessee, as described in Deed Book W18, Page 34 and shown on the Roane County Tax Map Number 46F, Parcel Number 8.01.

The Grantor certifies that they are the owner of the aforescribed property and have a perfect right to enter into this agreement and will defend the title to said property against any persons claiming otherwise.

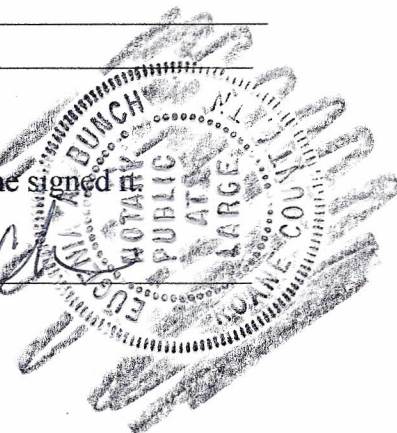
