


POWER LINE EASEMENT

May 17, 1960

For and in full consideration of \$1.00 and other good and valuable consideration, receipt of which is hereby acknowledged, we grant unto the Harriman Utility Board, operating agency for the City of Harriman, Tennessee, an easement described as follows:

A power line easement over and across a strip of land thirty (30) feet in width, and lying fifteen (15) feet on either side of the center line thereof, including all poles, anchors, guys and other necessary appurtenances, all located upon the property substantially as shown on a map attached hereto, and being a power line easement extending from the Leo Grant power line in the Sugar Grove Valley onto the property of the grantors a distance of approximately 1355 feet. Any dangerous trees lying outside this thirty (30) foot area that might fall into the line are to be removed by Harriman Utility Board,

for the purpose of installing, operating and maintaining, including the rights of ingress and egress, an electric power line with right of joint use by the Telephone Company, on and over our property in the Third Civil District of Roane County, Tennessee, said property being described as follows:

"Lying on the northeast shores of the Emory River Arm of Watts Bar Lake, approximately one mile north of the mouth of the said Arm of the Lake, and being all of the land lying above the 750 foot contour, and situated on the lakeward side of a line as described in Deed of record in Deed Book P, Series 8, page 99, Register's Office of Roane County, Tennessee."

This easement is granted to serve our property and other property, or properties. Any damage to fences, crops or other undue or excessive damages to be paid for by the Harriman Utility Board.

This easement signed this 17 day of May, 1960.
