It is further understood that if, for any reason, the District is unable to provide me with the water service anticipated by this application, the full amount of my deposits, (\$60.00), shall be refunded to me. I forther understand that any bonds issued or any loan obtained to finance the District's water works system will not be a lien against my property and no taxes can be levied to pay the bonds.
