It is my understanding that the initial minimum monthly charge shall be (\$4.50) for (3,000) gallons of water. Consumption in excess of (3,000) gallons will be charged for in accordance with a schedule of monthly rates, which will be published later by the Board of Commissioners.

It is further understood that if, for any reason, the District is unable to provide me with the water service anticipated by this application, the full amount of my deposits, (\$60.00), shall be retunded to me. I further understand that any bonds issued or any loan obtained to finance the District's water works system will not be a lien against my property and no taxes can be levied to pay the bonds.
